## 1 Introduction

The Federal Financial Supervisory Authority (*Bundesanstalt für Finanzdienstleistungsaufsicht* – BaFin) provides three different reporting channels for the electronic filing of final terms of the offer:

- (1) Submitting the report manually using a form on the "Reporting and Publishing Platform (MVP Portal)".
- (2) Uploading an XML file via the MVP Portal.
- (3) Uploading a report via the SOAP web service.

If reporting channel (2) or (3) is used, there are strict requirements regarding the format of the files to be transmitted. These requirements are specified by means of an XML Schema Definition (XSD). Reporting companies can access the key XSD file for the purposes of this document via the following URL:

<https://portal.mvp.bafin.de:444/services/ws/eft.xsd3.xsd>

This XSD specification must be taken into consideration when an XML-format report is created and also when the web service is used. The following documentation is provided as guidance.

When a report is submitted through the SOAP web service, the XML block specified by means of the above-mentioned XSD file is embedded in a SOAP message. The document [MVP-SOAP] referred to in the following section provides information on the form of this embedding. No further details are provided here.

## 2 Overview

For the specialised procedure "Filing of final terms of the offer" you will be able to electronically file the final terms of the offer as well as request the communication/cancellation of the communication of already filed final terms of the offer to other supervisory authorities.

The following types of reports can be filed:

- Filing pursuant to section 6 (3) sentence 3 of the WpPG
- Filing pursuant to Article 8(5) of the Prospectus Regulation
- Communication pursuant to section 6 (3) sentence 4 of the WpHG
- Communication pursuant to Article 25(4) of the Prospectus Regulation
- Cancellation of a communication pursuant to section 6 (3) sentence 4 of the WpPG
- Cancellation of a communication pursuant to Article 25(4) of the Prospectus Regulation

For each type of report there is a specific web form (see screenshot below).

In the form view, each of these web forms is shown as a list of sections. Details with a common context are bundled together within each of these sections. The sections are as follows:

- Details of the issuer
- Details of the final terms of the offer
- Communication to host supervisors or Cancellation of host supervisors
- File upload

Information on the issuer is inserted automatically into the form and cannot be altered.

Due to the particular way in which data is represented in XML format, the data transmitted via XML or using the web service are divided into six different basic elements for EFT reports:

1. eftMeldung
2. eftMeldungNotif
3. eftMeldungNotifCancel
4. reportFiling
5. reportCommunication
6. reportCommunicationCancel

Only the first three basic elements have subordinated elements (also called child elements) containing issuer data. The last three basic elements, which have been added in the latest version of the XSD files, do not have child elements.

To aid understanding of the XML format, screenshots of the implemented German-language reporting form will be provided in the remainder of this documentation.

### 3 General XML structure for a report

The previous chapter provided an overview of the report contents. This chapter now shows how this general structure is represented in XML format.

Any reference to "types" in this document relates to the types used in the XSD files provided for this procedure, i.e. type definitions such as

```
<xsd:simpleType> ... </xsd:simpleType>  
or  
<xsd:complexType> ... <xsd:complexType>
```

However, in the XML examples the element names rather than the type names are provided throughout.

The relevant type information for the XSD files must be taken into consideration for the end nodes of the XML structure, i.e. the elements which are filled with the actual content (text, numbers, times etc.). These are mentioned in this document for greater clarity only.

In the following, "eft" is used as a namespace code for the types that can be used for an EFT report.

#### 3.1 Basic elements of an XML-based EFT report

As described above, XML-based EFT reports can have six different basic elements. The different basic elements and the corresponding element types are described below.

##### 3.1.1 Basic element `eftMeldung`

For the **Filing pursuant to section 6 (3) sentence 3 of the WpPG** report or submission, the basic element designated as `eftMeldung` is to be used. The type of this basic element is `eftMeldungHinterlegungType`.

## 3.2 Overview: content structure of EFT reports

For EFT reports, six different types of submissions are available, each of which has their own basic element in XML. These basic elements are as follows:

1. eftMeldung
2. eftMeldungNotif
3. eftMeldungNotifCancel
4. reportFiling
5. reportCommunication
6. reportCommunicationCancel

In the following, the structure within these basic elements is described in greater detail.







## 6 Use of MTOM

### 6.1 Connecting to the web service

For several specialised procedures it is necessary to send the files as an MTOM attachment. This also applies to the latest version of this specialised procedure: if the web service interface is used, the file must be transmitted via MTOM in the original format (here: PDF) without encoding or compression.

This means that the file must not be compressed, base64-encoded or otherwise encoded or transformed, such as quoted-printable, UUencode, etc.

In order to reduce the data volume transferred, the request must be compressed using HTTP compression (RFC 2616). For reasons of compatibility, only the "gzip" compression method may be used.
